NO. TAX-436/95 Pt. – In exercise of the powers conferred by Section 103 of the Arunachal Pradesh Goods Tax Act, 2005, (Act 3 of 2005) the Governor of Arunachal Pradesh hereby makes the rules to amend the Arunachal Pradesh Goods Tax Rules, 2005, namely:-

### 1. Short title and commencement:

- These rules may be called the Arunachal Pradesh Goods Tax (Amendment) Rules, 2005.
- They shall come into force with effect from the date of their publication in Arunachal Pradesh Gazette.

#### 2. Amendment of Rule 12:

In Arunachal Pradesh Goods Tax Rules, 2005 in Rule 12(9), clauses (a) (b) (c) & (d) shall be substituted by the following, namely:

- "(a) RN = 0.15% if the business deals predominantly in goods specified in the Second schedule.
- (b) RN = 0.50% if the business deals predominantly in goods specified in the Third schedule.
- (c) RN = 2.5% if the business deals predominantly in goods specified in the Fourth schedule.
- (d) RN = 1.5% if the business deals predominantly in goods specified in the clause (d) of sub-section (1) of Section 4."

#### 3. Amendment of Rule 33:

In Arunachal Pradesh Goods Tax Rules, 2005, in Rule 33(3), clauses (a)(b)& (g) shall be substituted by the following, namely:-

- "(a) electricity bill in business name, Rupees 5,000.00;
- (b) telephone bill in business name, Rupees 5,000.00;
- (g) photocopy, if trading license issued by the competent authority, Rupees 20,000.00."
